

## **TREASURER'S REPORT 2020**

Thank you very much for electing me as Conference Treasurer last year. I would also like to thank my predecessor, Will Newport, for all his excellent work over the last five years as well as the support he has given me over the last few months.

I am most grateful to the Conference auditors, Jonathan Randall and Bruce Porteous, with whom I have conferred in relation to the accounts presented to you for the financial year ending 31 October 2019.

It had been my intention to correspond with the LDC regional lead contacts with requests for payment in April. I did send out an e-mail in early March explaining my intentions. However, the subsequent problems for the profession as a result of the Covid-19 pandemic led to a rethink.

It has been necessary for the LDC Conference account to carry a surplus to enable the Agenda Committee to book future venues, as well as to be in a position to facilitate a Special Conference if required.

I have decided to use this surplus to facilitate this year's virtual LDC Conference, and not bother LDC Treasurers during this very difficult period.

The Sustainability Transformation Partnership (STPs) implementation in April 2020 has created an additional complication for the calculation of the share of costs relating to each area, which is based on the proportions of NHS GDS spend per region.

I understand that this information will be available at the end of the Summer. I will work with Will Newport of the LDC Confederation and Alex Cenic of the BDA to make sure that my calculations have been scrutinized ahead of requesting payment later on this year to restore Conference funds to their normal level ahead of the 2021 Conference in Manchester.
